Public Utilities: Clerk Holm reported for Dave Ubel; water leak repairs have been completed at 216 Shady Oak Dr and old elevator, owners to be billed; main line loop has been completed into Kuester Pit addition from off Railroad Street south of grain bins.

Mayor Report: NONE

Planning Commission updated Comprehensive Plan Zoning Map. Mayor Poehler described the areas around the new highway. Clerk Holm reports Planning Commission will hold public hearing at next meeting April 17, 2025.

Mayor Poehler had Bolton and Menk prepare estimates on how to bring water and sewer to north of new Highway. The plan would have to be divided into eastern and western projects because of the topography of the land. Estimates to bring up east side of city to north properties is approximately 4 million dollars and completing the entire eastern portion an additional 4 million dollars. Costs for western are the same, another 8.1 million dollars.

Mayor Poehler has received another call for this information for one business. With these figures, the question was asked if the city would allow a well and septic for the one property. Council has mixed feelings about this. Councilmember Rodewald feels this would be going backward for the city. Additional discussion on allowing and should utilities become available, connection would need to be completed in specific timeframe. Councilmember Bode adds that if one comes, it could bring more. Mayor Poehler also has been approached if a plat would be allowed north of the highway to build a shouse subdivision with shared well and individual septic. Councilmember Rodewald would like to see assurance on viability of wells and septics from Nicollet County and Department of Health. The type and name of the business is unknown, council feels this information is necessary to give an informed decision.
