Public Utilities: Dave reports on pond and possible solutions to gate valve from plugging up with brush debris. Council discussed options to screen the gate valve and possible chemicals in the spring to reduce weed growth.

Dave also brings up brush on Riverview/MaryLane and continued discussion on asking residents to trim/cut trees that are growing in ditches. Discussion with council on what should be trimmed/cut back, Dave suggests cutting back 10feet from bituminous. Mayor Poehler suggests sending letters to residents requesting to take care of or the city will be doing so. There are also properties that have growth that is on the noxious weed list and these properties should be included. Council directs clerk to send letters to properties identified by Dave and Councilmember Marti with verbiage "remove all

trees and brush within 10feet of edge of bituminous".

Dave also reports on Collin Drive and washout behind curbs has worsened since previous discussion. Dave asks council to approve having city cover costs to put tar aprons behind to curb to protect it. Dave will discuss with Bolton & Menk. Dave reports on continued Lead Service Line project, grant was received to cover costs.

Mayor Report: Mayor Poehler reports there is new information on sewer line extension from MaryLane up to

Planning Commission: Public Hearing held for Mary Lane Addition Final Plat for MN Hardwoods LLC

Clerk Report: The office will be closed September 12, 2025.

Pay Request No41 WW Blacktopping – 2024 Street & Storm Sewer Improvements is presented for approval. Final wear layer was done recently. There is still retainage owed and will come at a later date.

Rodewald made a motion to approve Pay Request No 4 WW Blacktopping in amount of \$35,561.70. Kraus seconded the motion. Motion carried with all in favor.

Al Poehler presents information on ALCOR No 4 development. Poehler has obtained new information with cost projections for putting in sewer line up from Mary Lane. The costs are double what was previously projected at last month's meeting and there has been some development of information found that it will not be possible to put the line in as the property has protections under a study done by Minnesota Biological Survey through the DNR. This is an ecological study on grass and trees in the area and covers the entire parcel from Mary Lane up to the bluff. The area is previously undisturbed and is protected and cannot be disturbed for development. This also prevents using the bluff for holding pond as previously mentioned. The costs are becoming prohibitive for the development to move forward.

Mary Lane Addition Final Plat is presented for consideration. Council tables until next month.

2026 Budget and Preliminary Levy work session will need to be scheduled. Clerk Holm has prepared worksheets to review for the work session. Meeting scheduled for September 10, 2025 at 5:30pm, clerk will post notice.

Discussion on having Nicollet County Sherriff enforce ordinances as previously discussed. Rodewald will bring to next month meeting.

Rodewald made a motion to adjourn. Marti seconded the motion. Motion carried with all in favor.
