Randy King with Prokore Inspections is here to present council with information about services Prokore offers in regard to inspections. Currently the city is contracted with the City of New Ulm for inspections and use their fee schedule. Permit fees are calculated on this schedule along with state surcharge and administrative fee. The permit fees are remitted 100% to New Ulm. An initial contract with Prokore Inspections would have us remit 70% of permit fees and keeping 30% and no additional admin fee would be calculated. Council and Clerk Holm pose questions on process and related fees. Prokore does offer some virtual inspections that started during the pandemic and will continue which offers flexibility in completing inspections. Council is in agreement the change would be beneficial for the city and its residents and businesses.

Council Reports: Councilmember Rodewald will be attending a Region 9 meeting in the coming week and will announce there she is resigning that board.

Clerk Report: Clerk Holm notes upcoming Election Day, November 8, 2022. The city office will be closed November 11 for Veterans Day. Also for council to note December 1, 2022 meeting will begin at 6:30 for TNT hearing.

Clerk Holm presents information again on changing city website to through Municipal Impact. Currently the website is hosted through NuVera for \$9.95 per month with Julie handling the updates. Recently Julie found that our contact page is not sending emails to her and it is a technical problem with the site which requires more knowledge than she can do. The change of sites would also come with the benefit of an alert system residents could subscribe to by email and or text. Cost to make the change is \$349 for setup and year hosting subscription of \$565.95. Additionally in the future other upgrades to making payments and applications can more easily be incorporated into site. Council is in agreement for the need to update and direct Julie to move forward with the change.

Councilmember Rodewald recently met with Courtland Cubs baseball manager John Giefer regarding a campaign to make upgrades to equipment at the Ballpark. These improvements include the scoreboard, outfield fence and lights. The costs are adding up to \$300,000. Mr. Giefer has plans for wide reaching fundraising campaign. Since this a large undertaking, dollars raised will most likely not be enough. In the past, the Association has gotten loans for improvements and could likely do so again. A question has been raised to City acting as bank to supplement possible gap in funding or more. The question would need to be directed to legal on use of public funds. Clerk Holm will direct an email to city attorney.

City investments in 4M Fund. Clerk Holm has received information regarding CD return rates and what would council like to do with funds put into 4M Fund. Council discuss options of 3 month, 6 month and 1 year CD and rates. Council discuss best options to garner higher returns.

Bents made a motion to invest 4M funds, \$200,000 in a 3 month CD, \$300,000 in 6 month CDs and \$300,000 in 1 year CDs. Rodewald seconded the motion. Motion carried with all in favor.

Rodewald made a motion to adjourn. Peton seconded the motion. Motion carried with all in favor.
