John Stadick is present to question shaping the ditch by his house at 107 Wishbone Way as water will pool with only an inch of rain. It pools between his property and his neighbor to the north. Stadick explained that there is about a 12 inch rise from his culvert to his neighbor's culvert. The culverts are clean, the ditch between the houses does not allow the water to flow properly to the south toward the pond. Dave Ubel reports the homeowners have approached him about putting in storm sewer with storm drain in ditch and willing to be assessed for the project. John also has another issue to present for another neighbor in the cul-de-sac to the west with flooding from Hazel Lane sheds in the spring and heavy rains. After discussion, council aggress to take a look at the issues and then decide what needs to be done.

Mayor Report: NONE

Council Reports: NONE

Public Utilities: Discussion on notice to homeowners and businesses where issues were found during sewer televising. Council had questions on receiving a report on the project with the laterals of the most concern to be addressed as well as lines that need to be cleaned. Ubel reported jump drives with all the data have been received, but each has to be viewed individually and will be time consuming to find those that are in need of immediate attention to get notice letters out. Ubel will check the bid package again for details and contact the company about a report. Additional discussion on mainline that will need to be jetted, Dave is contacting a company to proceed with this.

Dave reports Nuvera continues to work on installing fiber lines in the City but they are not removing old copper lines with he feels could be a problem in the future when locate calls come in for any digging, the lines will be located along with the new fiber line and may cause confusion.

City Clerk: Clerk Holm made note of holidays for November the office will be closed, Friday November 10^{th} for Veteran's Day and Thursday November 23 and Friday 24^{th} for Thanksgiving.

Clerk Holm presented the bill from Underground Technologies for approval. Discussion and review leads to making partial payment of \$57,360 until receive clarification on other items on bill and report on all the laterals.

Rodewald made a motion to pay Underground Technologies of Minnesota \$57,360.00 partial payment of invoice No. 575. Bode seconded the motion. Motion carried with all in favor.

Kuester Pit 2 Second Addition: Jason Kuester is present to discuss letter received from city attorney on non-completion of development by date of agreement. The project deadline was in July, Mayor Poehler questions why no update was given when the completion was not going to be done by the expected deadline. Mr. Kuester reports delays for gas and electrical work to be completed that caused dirt work not to be completed. Mr. Kuester indicated work is being done now, leveling of dirt and shaping ditch for water flow. Seeding and mulch to be put down and if does not grow, he will reseed in the spring and clean up mulch as neede. Mr. Kuester indicated not all dirt will be leveled and will have erosion control done by end of week. Councilmember Bode did ask again as to why if work was not going to be completed by project date, why city

was not informed and also the project calls for all dirt to be leveled to specifications in the development plans given to the city when the project began.

Collin Drive Feasibility Study: Mayor Poehler has asked Joe Duncan with Bolton and Menk the process to move forward with Collin Drive Street improvements and assess the properties for the work. Mr. Duncan sent over a draft resolution the clerk has prepared for review. The project will be 2024 Street Improvement Project.

Rodewald made a motion to approve Resolution 23-109 Authorizing Preliminary Report For The Proposed 2024 Street Improvement Project. Bents seconded the motion. Motion carried with all in favor.

Bents made a motion to adjourn. Rodewald seconded the motion. Motion carried with all in favor.
